After thoroughly looking at all aspects, statements, background information, and reading Lt. Mike Edward's findings associated in this complaint, I concur that the complaint against Office Akins is **partially sustained**.

This complaint was originated after Officer Jeremy Akins responded to a disturbance with a gun at SITEL Corporation located in Research Boulevard. This is a twenty four hour business with several employees on the property. Officer Akins confronted multiple people at gunpoint and used disruptive and vulgar language while doing so. Additionally, Officer Akins approached individuals with his video not turned on. The complaints advised that Officer Akins was extremely unprofessional during his initial contact with them calling out "hey Buddy, you got a problem" in an aggressive tone. Office Akins turned on his video after he initially approached the crowd.

In reading the complainants (Walter O'bryant, Vanessa Miles-Bush, and LaMarcus Bush) statements, it's gather the complainants believed the officer was out of order in reference to his duties (unprofessional, attitude, and anger). Mr. O'Bryant, Mrs. Miles-Bush, and Mr. Bush) statements are attached for detail viewing.

After viewing all the statements, videos, passed complaints, passed counseling documents, etc. It's my belief that Officer Akins could have handle the situation better. Officer Akins most certainly have the right to give loud commands to get compliance of a subject; however, he should not use vulgar/foul language in doing so. Officer Akins commanded two subjects to get on the ground. One of the subject he told to "Shut-Up" the other he stated "Don't what the fuck me". It's my theory if subjects are following your command, there's no reason to use this type of language. Officer Akins even went as far as to mimic a victim in the victim's present. Officer Akins conduct should be in a manner to minimize the possibility of having to use force and not maximize the possibility.
