PERSON MAKING COMPLAINT (Complainant):


In your own words, please describe as specifically as possible the documents you requested and give any reasons why you believe the records should have been produced to you.

On 19 April 2017 I requested copies of any public records including emails, records of interviews, fuel quantity log sheets from Starkville airport or any written correspondence relating to the investigation of the Mayor of Starkvilles investigation into my claim that the city of Starkville sold aircraft fuel belonging to Grassroots Aviation.

As of today almost one complete month after this request the city of Starkville has not responded in any way. There appears to have been no attempt to write, e mail or call or contact me in any way.

The documents should be produced because they are relevant to my claim that the city of Starkville owes Grassroots Aviation (my Company) \$2081.56, for aviation fuel.

Since Starkville claims they conducted an investigation and concluded the fuel in question does not exist they should then be able to produce the records of such investigation.



- 1. A copy of the invoice sent to Starkville Airport manager dated 24 Jan 2017 This invoice was never acknowldged in any manner.
- 2. A copy of the letter read to the Starkville board of Aldermen dated 7 Feb 2017. The fuel inventory is addressed on page 3. It was at this meeting that Mayor Wiseman promised a full investigation.
- 3. I met with city attorney on 14 Feb 2017 and provided copies of my fuel inventory sheets showing my record of 10.5 inches of Jet fuel and eight and seven eights inches of avgas. copies of those sheets are attached.
- 4. A copy of the Mayors letter dated 31 March 2017 staing that his investigation found the fuel level was to low to be measured.
- 5. I have also attached a fuel tank level chart showing the amount of fuel I had and the showing that the tank level can be measured down to one eight of an inch.

Additionally I would like to inform the Ethic Commision that I do not consider myself a "Bad person" or anything else. I am just a citizen wishing to hold a local government accountable for their actions and doing my best to see them act in a fair and responsible manner.

Reviewing my year end fuel sales it has come to my attention that we never settled up on the fuel that remained in the fuel storage tanks when Grassroots Aviation left the airport on 29 February 2016. As you will recall when Grassroots Aviation opened its doors on 3 March 2015 you witnessed measuring of the residual fuel by stick, the calculations and the settlement between myself and RAS.

When Grassroots Aviation left Starkville the airport put fuel on top of my inventory prior to sticking the tanks with me present. I contacted the city attorney who directed me to send the airport an invoice. Since the airport has made no attempt to reimburse me for this fuel I am now as per direction of the city attorney presenting the airport with the following invoice.

- 1. Jet A On Feb 27 2016 10.5 inches or 528 gallons purchased on 12/16/15 for \$1.67 my cost total due \$688.04
- 2. Avgas- On Feb 17 2016 8 7/8 inches or 412 gallons purchased on 1/13/16 for \$2.64 my cost total due \$1393.92
- 3. Total due for both avgas and Jet A is \$2081.56

I am also inclosing my fuel inventory sheet from that time frame. You have the tank capacity chart I used and copies of the invoices which also show the prices I paid. As always I ask if you have a question or comments on why this should not be paid please feel free to write or call.

Mayor and Aldermen,

Thank you for giving me a few minutes to express a few issues that I feel you need to be made aware of and that I feel require your attention.

For just a little background you may recall my company Grassroots Aviation Inc. operated the FBO in Starkville from March 2015 until 29 Feb 2016. During that time we never had any negative complaints we only had very positive comments and internet reviews on flight planning programs. We were responsible for welcoming numerous dignitaries and congressmen, governors and ambassadors to Starkville treating all travelers with the greatest respect and courtesy. Our business exceeded all expectations and even Budget Rental cars reported to us they had their best year ever.

On 2 Feb 2016 the Board of Aldermen cancelled our lease giving us a 90 day notice to wind down our business and close our doors. We closed all of our accounts, phone service, we sold our inventory. We closed our doors as directed on 29 Feb 2016. Even up until that day every customer who needed fuel was able to buy it from Grassroots Aviation.

On 18 February 2016 I notified the Airport Manager that Grassroots Aviation last day in Starkville would be 29 Feb 2016 to which the Airport Manager replied who is going to sell fuel? To show how much goodwill Grassroots Aviation has toward the city of Starkville Grassroots Aviation put together an interim proposal to sell fuel during the transition to a new FBO. Your airport board rejected this proposal and again on 29 Feb 2016 Grassroots Aviation closed all accounts including its credit card processing account even mailing the credit card machine back to the vendor.

I would now like to make you aware of several issues that has surfaced since Grassroots closed its doors on 29 February 2016

On 2 December 2016 I received a phone call from a gentleman questioning why Grassroots Aviation had billed his credit card during the months of April, August. September and October 2016 for a total of \$131.57. I informed him I was unaware but I would research the issue and asked him to do the same from his end.

This gentleman called back several minutes later to state the issue was he had swiped his credit card at the self-serve fuel terminal at the Starkville Airport. He stated that the airport manager knew and was aware that people buying fuel at the Starkville Airport were getting bank statements indicating they were being billed by Grassroots Aviation. The airport manager is reported as stating that he was unable to change anything until "the board met" on Tuesday night.

I contacted all three of companies involved in processing of credit cards while Grassroots Aviation was at Starkville.

Imagine my shock and dismay when Ms. Karen Bain of QT pod called me to explain that she had discovered the City of Starkville had been processing credit card transactions using my old account that had been reactivated in March of 2016 just weeks after I had closed it. Ms. Bain indicated she had just called the Starkville Airport Manager who stated that he did not want the Grassroots Aviation account closed. That he needed some type of board approval. I directed Ms. Baine to again stop the use of my account by the close of business on 2 Dec 2016 which she did but only by having to threaten the Starkville airport manager with shutting off the fuel terminal.

I contacted Mrs. Lynn Weyerhaeuser of Eastern Aviation Fuels. Mrs. Weyerhaeuser stated she had no control over the fuel terminal but she was aware the Starkville Airport manager was using my credit card processing account. Mrs. Weyerhaeuser stated it was a weekly phone call to try and get the airport manager to stop using the Grassroots Aviation account. Mrs. Weyerhaeuser works close with QT pod and stated Mr. Bill Eckord of QT pod and herself had "hounded and badgered" the Starkville airport manager to stop using the account of Grassroots Aviation to process credit cards.

Mr. Mayor, and Aldermen. What the Starkville airport has done here fits the exact definition of identity theft. The airport manager has used the credit card processing account of Grassroots Aviation knowingly and without permission for the benefit of the airport. And he refused repeated request to stop this action. This action has also resulted in a payment card data breech as over 240 customers of the City of Starkville airport unknowingly gave their credit card information, aircraft registration, addresses etc. to a third party without their knowledge or consent.

I am asking you as community leaders to imagine my position. Consider the liability exposure this action by a city employee exposed my company to. For several months the airport operated selling aircraft fuel under the name Grassroots Aviation while no employee at the airport had any formal training on fuel quality control procedures. What if the city sold contaminated fuel resulting in an accident or aircraft damage while under the name Grassroots Aviation?

I am asking you as community leaders to consider the credit card data issue. Grassroots Aviation maintains payment card industry standards. It is referred to as PCI compliance. Having untrained and unauthorized personnel handling credit cards and credit card reading equipment under the disguise of Grassroots Aviation without my knowledge exposed my company to an unacceptable risk. The Starkville Airport circumvented all credit card security requirements.

As community leaders I am sure you cannot condone this behavior by a city employee. Any excuse of well they let me do it so I did is blatantly irresponsible and unacceptable. I am asking you to hold your employee accountable for this and ask what corrective action do you intend to take? Does the city feel an obligation to address the breech of credit card data? Would Starkville like for me to invoice the city airport for the use of my credit card processing account?

An additional issue has risen from the fallout of Starkville's unauthorized use of my credit card processing account. US Bank has reported to the Internal Revenue service \$37,461.89 in proceeds from the City of Starkville's sale of aircraft fuel. These proceeds are listed as being received by Grassroots Aviation. The Internal Revenue Service will be expecting Grassroots Aviation to report this as income on

our corporate tax return when in fact no such proceeds were ever received. I am asking the how Starkville plans to address this issue so that I may file my tax returns on time. Will Starkville contact US Bank to get a corrected 1099 issued and does Starkville plan on reimbursing me for any increased tax liability caused by your city employee's unauthorized use of my credit card account?

I would also like to bring up an action typical of your airport manager and airport board. Recall that we did our best to provide for a smooth transition to a new FBO but was rejected. It was on 26 Feb 2016 three days before we closed our doors that the airport manager and an airport board member entered the locked offices of Grassroots Aviation after hours and removed keys and books. There was no emergency or crisis that warranted such action. They then received fuel after normal working hours into the avgas storage tank under the muse that I had abandoned the tank when in fact Grassroots Aviation was still in business at the airport. This fuel receipt into the storage facility had the effect of comingling fuel inventories. Normally when one FBO leaves and a new one arrives a fair orderly professional transition takes place and fuel inventories are purchased by the new FBO. I have waited for the airport to reimburse me for my inventory but nothing has happened. The airport manager is now in receipt of an invoice for this action and I would like the city of Starkville's input on this action. Do you agree with the actions of your airport manager and board member? Do you feel the airport should pay this invoice?

To conclude

Grassroots Aviation always acted fairly, professionally and with the best interest of Starkville in mind. Grassroots Aviation was very highly recommended by all that came to Starkville. We employed 8 linemen. We paid all bills on time. We provided maintenance, spare parts, rental cars, aircraft fuel, food delivery and a host of other services. In return our contract was cancelled. The City of Starkville started using our credit card processing account unlawfully. There is a breach of credit card security that needs to be addressed. The airport manager and airport board enters offices after hours at will to do as they please. The airport board has been found in violation of public records laws and open meeting laws. The airport manager takes over inventory then fails to pay for it. Public internet reviews of the service at the airport has faltered. I am asking you as Community leaders to look at each and every one of the allegations I have bought before you to see that they are addressed in a fair and honest manner.

Would the Board of Alderman find it acceptable to give me a written reply to these issues and concerns with in two weeks. I would also like a copy of this letter placed into the board minutes if possible. Thank you very much for your time and consideration in this matter and I stand before you ready to answer any questions you may have.
