Title: DOMESTIC

On October 10, 2016 I (Officer Potts) was dispatched to 1218 Military Road to speak with Ms. [REDACTED] in reference to a disturbance that occurred at 1326 15th Street North.

Upon my arrival, I spoke with Ms. [REDACTED] who stated she returned home around 1939 hours on October 10, 2016 after being away from home all weekend to get some clothes. Ms. [REDACTED] stated she began walking out of the house when she stated her dad (Kabir Karriem) walked into the house stating, "I don't know where you think you're going" and then pushed her. Ms. [REDACTED] stated she left walking westbound on 14th AVE towards Military Road. Ms. Karriem stated she came to the back parking lot of Swoop Real Estate and noticed her dad driving her mother's van. Ms. [REDACTED] stated her dad jumped out of the van and then began punching her. Ms. [REDACTED] stated her dad punched her three times in the head with a closed fist. Ms. [REDACTED] stated she believes the reason why her dad quit hitting her was that the van began rolling backwards and hit a no traffic through sign that is property of Swoop. Ms. [REDACTED] stated her dad ran towards the van to try and put the vehicle in park, at this time she stated she ran back home to get her phone and called friends to come pick her up at Wheeler's Roofing on Military Road where she called 911. I did not see any visible injuries on [REDACTED]. [REDACTED] did state that she didn't want to cause her dad any problems because of his position.

I spoke with Ms. [REDACTED] mother at 1326 15th Street North who stated her daughter has not been home since Friday and came home this morning wanting me to take her to school. Mom stated I let my son use my van to go to football practice and was not able to take [REDACTED] to school. Mom stated [REDACTED] started talking very disrespectful and mom said I am not doing this today you can just leave. [REDACTED] got her stuff together and left. Mom stated I began calling [REDACTED] around 3 and 4 p.m. I asked [REDACTED] where are you she stated you told "me to leave and it does matter where I am". Mom stated Kabir began texting her and told her to come home, and said if you are not home in 30 minutes you'll regret it, its real talk. Mom stated that Kabir stated she said fine I'd come get my clothes. Mom stated Kabir was already outside when she was walking up. Mom stated she was in the bed and heard Kabir stated you are being disrespectful and then [REDACTED] stated you got me fucked up and then ran out of the house. Mom stated Kabir left after her and came back home and stated I told her to get in the car and she told me "fuck you". Mom stated what happen at 14th Ave she does not know anything about.

I attempted to make contact with Kabir Karriem to get a statement but was not successful. I did sign an affidavit against Kabir Karriem for Domestic Violence/Simple Assault.
