A digital system does currently create and hold this data off site in digital form, and it is also stored and backed up daily. I support the unit system of government, where funds are allocated on the needs of the County as a whole, rather than an even split of funding.

Using the current methodology, our tax dollars are wasted by the process of paving a portion of a particular road, then later paying for someone to come back and pave another portion. The current process is akin to painting a room but only paying the painter to complete one wall; then hiring them to return and paint another wall.... until the room is completed. This inefficient system has led to many substandard roads, clogged ditches, and closed bridges.

By being more systematic and planning ahead, Oktibbeha County can save a significant amount of money by approving road projects based on the condition of the road, instead of which district the road is located. This in turn will provide more capacity for road improvements.

Unfortunately, the state of relations between Oktibbeha County and Starkville seems to have become adversarial. I have no doubt both parties are working from positions of what they perceive are in the best for their constituents, but the public spats do not benefit anyone and only degrade our image to outsiders.

I think both government bodies could benefit from regularly scheduled meetings, outside of instances when one is asking for something from the other. To build a better relationship, both sides need to approach any discussion with a bit of humbleness and be open to compromise.

In my experience the best negotiating tool is listening and approaching a conversation with the mindset that all parties have good intentions. Once that groundwork is laid, then both parties can negotiate in good faith to reach an agreement that benefits all. I feel this is a key skill I would bring if elected.

Oktibbeha County and all other local governments in Mississippi are facing a significant involuntary increase in employer contributions to the state retirement system. It is imperative that local leaders work with our legislators to find another solution to properly funding the system. Continually asking taxpayers to foot the bill for poor policy, management, and investment decisions is unreasonable and wasteful.

Additionally, the County seems

rudderless with regards to economic development policy. While we do employ various organizations to work on our behalf, there is a lack of direction. What makes Oktibbeha County competitive? Where can we improve? Why do businesses choose to locate elsewhere? These are the questions (amongst others), that we should be asking. We must be intentional and seek opportunities, rather than waiting for them to come to us. I believe with my education and experience (including \$2,000,000.00+ in grants); I am well suited to lead this discussion.



I think the difference between punishment and diversion depends on the nature of the crime, the recommendations of the victim, the criminal history of the person, and the best options for rehabilitation. In my eight years as DA, I've prioritized prison for violent crime because violence destroys families and communities. My office has a 95% conviction rate for indictments and over 85% for jury trials. I've personally led the prosecution of 26 violent criminals and gotten guilty verdicts in 24 of them with 1 hung. When it comes to non-violent crime, first offenders, I prioritize rehabilitation. For people suffering from substance abuse, I'll typically offer pretrial diversion services that try to connect them with rehabilitation services or job placement or educational services. For people suffering from advanced drug or substance abuse issues, I'll work with the Drug Court to determine if they have services that could be helpful.

The first problem with recidivism in Mississippi is our prison system does not have the resources to provide enough opportunity for rehabilitation. Too often what I hear from inmates is that they had to do everything in their power just to survive. Until MDOC is properly funded, the best way to reduce recidivism is to focus on young people. Over the next four years, I plan to work with the Youth Court to identify juveniles on the wrong track and partner with those courts to find resources and grants to help them provide services and mentorship. I also plan to work with the schools in my district to help identify troubled youth and determine what assistance can be provided to get them the guidance they need to reach their potential. This will take the involvement of community partners like churches, non-profits, and other community organizations.

The role of victims' advocacy in the district attorney's office is of paramount importance. Victims of crimes often experience significant trauma and emotional distress, and it is crucial for the justice system to prioritize their rights, needs, and support throughout the legal process. Here's how I have promoted victims over the previous four years. My office was the first in the state to offer grievance counseling for survivors of gun violence to help these survivors work with each other to learn how to live with the loss of a loved one. We were also the first DA's office in the State to offer tree planting ceremonies for victims of violence to symbolically help them deal with the long, arduous grieving process. Finally, my office has also prioritized restitution for victims of property crime to help them recover the financial loss someone's crime caused

A balance between punishment and diversion simply doesn't exist. Cases must be assessed and prosecuted on a case by case basis. Drug abuse cases and cases involving first time offenders of non-violent crime qualify for some form of "diversion." All others must be sentenced accordingly based upon the severity of their crime, their likelihood to re-offend and what type of threat they pose to society (usually evidenced by their criminal history). There is a fine line between placing the interests of a felon before the interests of your community.

ensure that individuals don't re-offend. All I can do is give a qualifying individual a second chance (completing a court program so they will not be a convicted felon), which puts them in the best possible position moving forward. I would like to be more actively involved in the community, particularly in our schools and youth courts, so we might curb some of this crime on the front end. More of our kids need to know who the district attorney is, what he does, and the reality of punishment awaiting them if they break the law. Not to scare them, but to educate them on reality before they make a decision which could ruin their lives.

I believe victims advocacy is vital in the criminal justice process. I believe that prosecutors owe a duty to the victims of crime to make them as whole as they could possibly be given the circumstance. Sometimes this involves affecting retribution in the form of a lengthy, or permanent, jail sentence. Other times this involves making them financially whole. My office will provide and type of special assistance needed, including assistance with applications to state and federal grants for victims. My primary focus will be putting criminals who create victims in a position where they fear the repurcussions so much that they never do it again, and in some cases, they won't be able to.
